4.2 Non HWM funds – Club Captain's Charity Fund £ 1311.85, Staff Gratuity Fund £ 1,394.86, Winter Pairs Entry Fees £ 160, 9 Hole Prize money £10. Total Non-HWM funds = £ 2,876.71 HWM funds are therefore (£ 4,025.80 less £ 2,876.71) = £ 1,149.09 Plus, VAT receivable £ 69.23 = £ 1,218.32	Note
